

Privacy Policy

We take your privacy seriously, and we want you to know how we collect, use, share and protect your information. Protecting your private information is our priority. This Statement of Privacy applies to www.thegleasoncenter.com and The Gleason Center and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Gleason Center include www.thegleasoncenter.com. Collection of your Personal Information

In order to better provide you with products and services offered on our Site, The Gleason Center may collect personally identifiable information, such as your:

Use of your Personal Information

Sharing Information with Third Parties

The Gleason Center does not sell, rent or lease its customer lists to third parties.

Tracking User Behavior

Automatically Collected Information
